Protesters facing Christmas in gaol

Two peace protesters who chained themselves to pillars outside the Ministry of Defence in London face

chained themselves to pillars outside the Ministry of Defence in London face Christmas behind bars.
Former magistrate Sarah Hipperson, aged 55, and Dr Ray Towey, 39, members of Catholic Peace Action, both refused to be bound over to keep the peace after being found guilty at Bow Street magistrate's court yesterday of behaviour likely to cause a breach of the peace.

They were clapped and cheered by supporters packing the courtroom as they left to start seven-day sentences imposed for their defiance.

Mrs Hipperson, now a full-time peace worker at Greenham Common, told the court she could not be bound over because by the nature of her work she would continue to protest against nuclear weapons.

In a statement issued on Tuesday after a CND protest in Trafalgar Square, Mrs Joan Ruddock, the organization's chairman, said that the small demonstration had been a

spontaneous reaction rumour that a cruise missile was to be taken out of Greenham Common Air base. "We would not have called any major demonstration at this time and we fully support police effort to find the perpetrators of Satur-day's appalling crime."

Mrs Ruddock was comment-

ing on a statement by a police officer at the protest complaining that police resources were being diverted from the hunt for the IRA bombers.

In the Commons yesterday, Mrs Thatcher criticized the protest and said that it would have been "nice gesture" if the organisers had called off Tuesday's demonstration day's demonstration.

The Prime Minister was replying to a question from Mr Tim Eggar, Conservative MP for Enfield North, who had condemned the protest for taking police officers away from street patrol duties.
